

Introduction

This information is for residents of East Sussex who wish to apply for an English National Concessionary Travel Scheme bus pass.

# 1.1 What is a concessionary bus pass?

A concessionary bus pass is issued as part of the English National Concessionary Travel Scheme and it allows eligible older people or those that are registered disabled to benefit from free off-peak travel on local buses anywhere in England.

# 1.2 How do I apply for a disabled persons bus pass?

Your sole or principal residence must be in the County of East Sussex (not including Brighton and Hove) and you will need to provide evidence that you suffer from one of the disabilities defined later in this information document.

Bus passes are produced by an external supplier so please allow at least 10 working days from date of eligibility. Please let us know if you have not received your pass by this time.

## 1.3 Where and when can I use the bus pass?

You can use the bus pass on local bus services anywhere in England.

For journeys that start in East Sussex, you can use the bus pass:

- 9am to 11pm, weekdays
- all day at weekends or bank holidays.

Outside of East Sussex, you may not be able to use the pass until 9.30am.

This includes Brighton & Hove, West Sussex, Kent, and Surrey. You could, however, board a bus in East Sussex at 9am and travel for free into Brighton or Tunbridge Wells, for example.

If you are using the bus pass outside of East Sussex, it's a good idea to check with the bus company you will be travelling with, to check local restrictions.

# 2 Applying for a disabled person's bus pass

## 2.1 Who is eligible for a disabled person's bus pass?

You're eligible for a disabled person's pass if you live in England and are 'eligible disabled'. This means you:

- A. are blind or partially sighted
- B. are profoundly or severely deaf
- C. are without speech
- D. have a disability, or have suffered an injury, which has a substantial and long-term effect on your ability to walk
- E. don't have arms or have long-term loss of the use of both arms
- F. have a learning disability
- G. You're also eligible disabled if your application for a driving licence would be refused under section 92 of the Road Traffic Act 1988 (physical fitness). However, you won't be eligible if you were refused because of persistent misuse of drugs or alcohol.

# 2.2 How do I apply?

All passes must be applied for **in person** either at a local East Sussex Library or at participating local council offices. See section 3 for a list of these.

There is no need to make an appointment and your pass will be sent to you within 10 working days.

# 2.3 What do I need to bring?

When you come to the library or council office, you will need to bring:

- proof of your disability
- proof of your address
- letter from your GP (if applying for a companion pass)
- a photograph of you (this can be taken for you, see below)
- your National Insurance number.

Please provide original documents. We do not keep these, but may take copies for our records. See below for a full list of acceptable documents.

## 2.3.1 Proof of your disability

All New applicants must provide the necessary proof as specified for their particular disability. Your application may be refused unless the exact specified proof is presented, so please read carefully.

Eligibility Category		Required Proof		
A	Blind or Partially Sighted.	<ul> <li>Proof of registration with Social Services</li> <li>A letter from an eye specialist, for example an optometrist, that you would qualify to be registered as severely sight impaired (blind) or sight impaired (partially sighted).</li> </ul>

D	Disability which has a substantial long term adverse effect on your ability to walk.	<ul> <li>In receipt of the Higher Rate Mobility Component of Disability Living Allowance for a minimum of 12 months</li> <li>Medical evidence that your walking ability is long term and substantially impaired</li> <li>SPVA Notice of Walking Disability</li> <li>In receipt of War Pensioners Mobility Supplement for a minimum of 12 months</li> </ul>
E	Long term loss of use of both arms or the loss of both arms.	<ul> <li>Letter from your G.P., Consultant, a Senior Practice Nurse or occupational therapist confirming your condition.</li> </ul>
F	Learning Disability	<ul> <li>Letter from your G.P., Consultant, or Senior Practice Nurse confirming that your learning disability meets the eligibility criteria.</li> <li>Proof of registration with Social Services</li> <li>For children – a letter from the head teacher at a special school confirming eligibility as defined.</li> </ul>
G	Refusal of Driving Licence/Unable to Drive due to medical reasons.  The pass must be returned if the restriction is lifted.	<ul> <li>Letter from D.V.L.A. confirming the refusal/revocation of a driving licence for a minimum period of 12 months. This does not include those excluded from holding a licence due to the persistent misuse of drugs and/or alcohol.</li> <li>A letter from your G.P. or another suitable medical professional confirming that you are most likely to be refused a driving licence due to your medical condition.</li> </ul>

## 2.3.2 Proof of your address in East Sussex (bring one of the following)

- a letter from Department of Work and Pensions
- a recent bank or credit card statement
- your current council tax bill
- a recent utility bill.

If your main home is not in East Sussex, you should apply for a bus pass to the local authority where you usually live.

Any proof of address must be no more than three months old. The date must be printed and not handwritten.

## 2.3.3 Photograph

## Libraries

If you apply at a library, staff will take your photo for you, free of charge.

## **Council offices**

If you apply at a council office, you will need to bring a photograph of yourself. This must:

- be a recent, colour, passport-style photo
- show your head, shoulders and full face
- be taken without any headcovering or tinted glasses. Ordinary glasses are fine.

## 2.3.4 Companion pass requirement

If you are disabled and need help to travel, you can apply for a companion pass which allows someone to travel with you free of charge. You do not have to always travel with a companion. Companions may be charged for travel outside of the East Sussex area.

As well as proof of your disability, you will need a letter/form from your doctor or consultant stating that you need help to use public transport.

Please tick the "plus companion" box on the application form if you are applying for a companion pass

# 3 Where do I apply

East Sussex Libraries (Disabled access is readily available at all these sites except for Pevensey Bay which has stairs leading down to the library)

present the application form so you will not need to provide a passport photo.

# 4 Fair Processing Notice – National Fraud Initiative

East Sussex County Council is required by law to protect the public funds it administers. The Council shares information provided to it with other bodies responsible for auditing or administering public funds. In order to assist with the prevention and detection of fraud.

The Audit Commission appoints the External Auditor to audit the accounts of this authority, and they are also responsible for carrying out data matching exercises.

Data matching involves comparing computer records held by one body against other computer records held by the same or another body. This is usually personal information. Computerised data matching allows potentially fraudulent claims and payments to be identified. Where a match is found it indicates that there is an inconsistency, which requires further investigation. No assumption can be made as to whether there is fraud, error or other explanation until further detailed investigation is carried out.

The Audit Commission currently requires the Council to participate in a data matching exercise to assist in the prevention and detection of fraud. The use of data by the Audit Commission in a data matching exercise is carried out with statutory authority under its powers in Part 2A of the Audit Commission Act 1998. It does not require the consent of the individuals concerned under the Data Protection Act 1998 to undertake the exercise

# Please read before applying

#### What do I do when I have completed the form?

Completed forms and supporting documents (see below) must be taken **in person** to a local East Sussex County Council library or your local district or borough council (except Lewes District Council).

- Proof of disability As listed for the category of disability you are applying for. Those applying for a
  companion pass should also include a letter/form from a doctor or consultant stating that you need a
  companion to use public transport.
- Proof of address letter from Department of Work and Pensions, recent utility bill, recent bank or credit card statement, recent council tax bill.
- If applying at a local council office you will also need a passport sized photo this must be a recent, colour, passport-style photo; show your head, shoulders and full face and be taken without any headcovering or tinted glasses. Ordinary glasses are fine.

You should provide original documents and we may make copies of these. Letters obtained from GPs and/or specialists specifically for the purpose of obtaining a pass will be kept by us.

## How long will it take to get my bus pass?

Bus passes are produced by an external supplier so please allow at least 10 working days from date of application. Let us know if you have not received your pass by this time. We are unable to accept responsibility for any items lost in the post.

## Statement in support of an application for a companion bus pass

The National Companion concessionary bus pass is intended for people who have applied for their concessionary bus pass on the grounds that they have a disability and their disability is such that they need to have a companion to travel with them some or all of the time. This type of bus pass allows the holder plus one companion to travel on buses within England free of charge, subject to certain conditions.

IMPORTANT: This form can only be used if the practice has a stamp to authenticate it otherwise a letter from the GP should be requested.

## Instruction to the applicant:

Please complete Section 1, below, and ask your GP to complete Section 2. Once the form is completed, you should take it, along with your other application documents, to any library or District/Borough Council office in East Sussex (details are given with the information that accompanies the main application form).

Your GP's practice may charge a fee, with which East Sussex County Council is unable to assist; however, you may ask your GP if they would consider waiving the fee, at their discretion.
